CONDITIONS OF ADMISSION

GENERAL

- The Signatories and the Pupil will be bound by the rules, regulations, policies, and procedures of Acacia as laid down by the Acacia Board, its Executive Committee and /or its Head from time to time. The Signatories confirm that by signing this enrolment contract, that he / she / they will have read, and discussed the school rules contained in the Code of Conduct with his / her / their son / daughter / ward, and agree to adhere to the Christian Ethos and Practices observed by Acacia.
- The Signatories and Pupil agree to abide by Acacia's Christian ethos, and conform to the spirit of Acacia's Christian-based education.
- The Signatories and Pupil agree and undertake to read and be bound by the Acacia "Code of Conduct" and any future amendments thereto.
- 4. The Signatories accept their responsibility to supply Acacia with any documentation as required by National Legislation, including medical information, study permits, academic records, etc. and accept that failure to produce the same may result in the Pupil being excluded from the School.
- The Signatories hereby acknowledge and confirm that they
 are personally liable for all terms and conditions herein
 and to be effected in terms hereof, including but not limited
 to: Acacia Code of Conduct.
- 6. The Signatories and the Pupils undertake at all times to uphold the good name and reputation of Acacia.
- 7. The Signatories accept that personal possessions of the Pupil are not covered in any risk insurance by Acacia and that the Signatories are responsible for supplying adequate cover for the Pupil's personal possessions.
- The Signatories accepts liability for any loss or damage suffered by Acacia arising from any conduct of the pupil, howsoever caused.
- 9. The Signatories understand that Acacia will constantly

- endeavour to take such steps as may be reasonably required in the circumstances to do what it can to ensure an environment free from harm and / or loss, taking into account what can be reasonably foreseen and provided for in the circumstances.
- 10. The Signatories hereby indemnify and hold blameless Acacia, its shareholders, directors, employees, and agents against any loss, damage or injury which may be sustained from whatever cause excluding gross negligence, whether on Acacia property or en route thereto or therefrom or in the course of any extra mural activity or organised outing in which the Pupil or Signatories may participate.
- 11. The Signatories understand that the information contained in the enrolment contract constitutes a material representation relevant to the acceptance of the enrolment of the Signatories' child as a Pupil and the Signatories warrant that all information contained in the enrolment contract is true, complete and accurate.
- 12. The Signatories further agree that any change in information supplied in this agreement including but not limited to the Signatories marital status, residential status, employment status or contact details does not alleviate the agreement made herein, and any such change will be reported in writing to Acacia.
- 13. Any relaxation or deviation from the terms of this agreement, which may have arisen in the past or may arise in the future, shall not be deemed to be a waiver of Acacia rights to enforce strict compliance with these conditions without further notice.
- 14. This agreement shall be deemed to be concluded upon the enrolment of the Pupil by Acacia, and on the payment of the non-refundable registration and admission fee stipulated by Acacia and shall constitute the whole agreement between the parties and no amendment, alteration, addition, variation, representation or warranties, whether expressed or implied, will be of any force or effect unless reduced to writing and signed by both parties.

- 15. All legal correspondence between the Signatories and sent by Acacia shall be delivered by hand, either directly to the Signatories or via the Pupil or sent by pre-paid registered post. The correspondence shall be deemed to have been received on the date of delivery or on the 5th business day after posting. In regard to all correspondence by the Signatories to Acacia, the onus of proof of delivery shall rest on the Signatories.
- 16. The Signatories acknowledge that Acacia shall be entitled to recover all legal costs incurred by it, in order to enforce its rights under this agreement, including but not limited to attorney and own client fees and collection and tracing charges.
- 17. The Signatories understand that by signing this form they consent to Acacia conducting whatever enquiries may be considered necessary to verify any information given in this application, including confirming their credit rating with a national Credit Bureau and contact with previous schools of the Pupil.
- 18. On termination of this agreement for any reason whatsoever, the Signatories undertake to immediately withdraw the Pupil from Acacia and to make satisfactory arrangements for the Pupil's attendance at any alternative school.
- 19. Acacia shall be entitled to cancel this agreement by giving the Signatories 3 (three) months written notice to this effect.

PAYMENT OF FEES

- By enrolling your child at Acacia, you are investing in his/her education. This investment comprises our school fees, levies (which are announced on an annual basis), subscriptions and any other amounts that you have to pay from time to time. Please ensure that you pay the requisite fees on time. For convenience we refer to "school fees" in this agreement.
- "Levies" refers to an amount budgeted each year for compulsory school activities, such as outings and camps.
 "Subscriptions" refers to amounts due for non-compulsory extramural activities, such as sports and tours.
- 3. The Signatories accept joint and severally liability to Acacia for the punctual payment of all fees, subscriptions, levies, and other amounts that become due and payable to Acacia, or in respect of participation in, or attendance at school-related activities. Any bursary or sponsorship in favour of the Pupil relates only to school fees.
- 4. The Signatories agree that they shall be jointly and severally liable to pay tuition fees, as prescribed in the Schedule of

- Fees, from time to time, and any special levies imposed by Acacia, and that they have sufficient funds to meet the financial commitments herein. The school can claim the entire outstanding amount of school fees from either or both of you, regardless of your marital status or divorce order.
- 5. The Signatories accept that fees are payable annually in advance on or before the first day of attendance of the Pupil at Acacia unless arrangements have been made in writing at the sole and absolute discretion of Acacia for the payment of tuition fees, by cheque, debit order or EFT. A debit order instruction form will be provided and must be returned as part of the registration process. No payments in cash will be accepted.
- 6. If arrangements have been made or will be made for the payment of school fees, each instalment shall be paid on the first day of each month or on the first day of each term as the case may be.
- 7. A statement issued by the school Financial Administrator certifying the balance owing from time to time shall be valid and sufficient (prima facie) proof for all purposes of the amount owing by the Signatories in terms hereof.
- 8. A poor payment record may impact the standard payment terms available to parents.
- The Signatories acknowledge that the inability of the Pupil
 to attend school or the absence of the Pupil from the school
 does not relieve the Signatories of the obligation to pay
 school fees.
- 10. The Signatories agree to provide a non-refundable admission and application fee as a condition of enrolment.
- 11. In the event of the Pupils€™s expulsion from Acacia the parent/s or guardian/s will be refunded on a pro-rata basis, if they have already paid the school fees for the term or for the rest of the year.
- 12. Failure by the Signatories to pay any amount on due date constitutes a breach of this agreement. Should the Signatories fail to remedy the breach within the time period specified in any notice, this may result in the cancellation of the agreement. On breach, the balance of the annual tuition fee will be immediately due and payable and may be retained Acacia as a cancellation fee.

SERIOUS CONSEQUENCES OF LATE OR NON-PAYMENT

- 1. Any late or non-payment of school fees, levies or subscriptions may have the following consequences at the absolute discretion of Acacia:
- a. Services provided by Acacia may be withdrawn if you are 3 months in arrears. Further, the school's contract with the parent may not be renewed; and the school will not re-enroll the child(ren) for further studies at Acacia.
- b. Your child may be prevented from taking part in any extramural activities.
- c. Any special discount granted by the school will be revoked.
- d. The full annual fees will become due and payable by the parent(s)/guardians.
- e. The school may report the slow or non-payment of the parent(s)/guardians to our credit bureau; and this may affect your creditworthiness.
- 2. Acacia charge administrative fees for any cost relating to returned debit orders, refer-to-drawer (RD) cheques, reminders, letters of demand or other fees relating to the collection of payment. We recover any legal expenses that we have to incur to collect payment from you, including any attorney fees at the actual rate charged (that is, the attorney-and-own-client scale), any collection commission and tracing fees.

CANCELLATION WITH THREE MONTHS' NOTICE

- 1. The Signatories are entitled to terminate the contract with three calendar months' written notice.
- 2. If no notice is given, you will be liable for three months school fees in lieu of the notice.
- 3. No indulgence which Acacia may grant to you will constitute a waiver of any of its rights unless reduced to writing and signed by an authorised representative of Acacia.

PERSONAL INFORMATION

- 1. Personal information means information that can be used on its own or with other information to identify, contact or locate a person or to identify an individual in context.
- 2. The Pupil and insofar as may be required, the Signatories, understand, accept and consent to Acacia collecting

- personally identifiable information about pupils and Signatories only to the extent necessary in terms of this agreement.
- 3. In obtaining your personal information through this form or related forms, Acacia are legally obliged to respect your privacy and that of your child.
- 4. The school uses your child's and your personal information only to deliver quality educational services, to ensure your child's health and safety and to comply with applicable legal requirements.

ACCURACY OF AND CHANGES TO PERSONAL INFORMATION

- 1. The accuracy of your child's and your personal information is extremely important to Acacia. Please take the time to ensure that it is true, complete and accurate. By signing this document, you warrant that this is the case.
- 2. You are required to inform us immediately if any of your personal information changes (e.g. your marital status or your contact details or residential address).

VERIFYING YOUR INFORMATION

- 1. By signing the contract, you give us permission to conduct enquiries to verify the information that you gave us as part of this application and to check your creditworthiness. This includes contacting your child's previous school(s) and conducting a credit check.
- 2. Acacia will not disclose your information to the public or to any third parties without informing you.
- Your child's next school may contact us to obtain information about you and your child in order to verify admission criteria and your creditworthiness. We disclose only the necessary information in response to such enquiries. By signing the contract, you consent to such disclosure.
